Targets and goals

- strives, together with the manufacturers, towards a continuous improvement of equipment to create a safer working environment
- represents the mobile crane users in the NEN-EN 13000 norm committee
- works to harmonise equipment travel rules, general conditions of work and to harmonise permitting regulations throughout Europe
- maintains an inter-European network for national Associations, companies and manufacturers
- strives towards a continuous improvement of the image of the sector
- wants to enhance the quality provided to our clients and promote safer ways of working
- exchanges information between the ESTA members, allowing them to work together all over Europe
- represents the European Heavy Lift industry in the international ICSA organisation and the Abnormal Transport industry in the IRU.

Successes

European Best Practice guideline

In 2000 ESTA issued a Black book with a comprehensive list of different problems because of the lack of European harmonisation. In the Black book ESTA asked for European corridors for abnormal road transports. As a direct result the European Commission started with an EU Expert group who is responsible for a Best practice Guideline. This document will provide member states and permit authorities with guidelines for permit procedures and regulations.

ESTA Awards

Each year ESTA organises the ESTA awards ceremony and dinner event during which the ESTA Awards of Excellence for the most outstanding lifting and transport projects are made public.

Harmonized European form

ESTA developed a harmonised European form and software for the technical admittance of trucks and trailers in permitting procedures. [SERT]

ESTA General Conditions

ESTA has developed standard "Terms and Conditions concerning Crane hire, Crane work and Transportation services" that comply with European legislation can be downloaded from our website and offer a comprehensive set of conditions for the execution of activities by our members throughout Europe.

SPMT Best Practice guide

Together with Industry subject matter experts ESTA has developed and published a "SPMT Best Practice Guide" that gives guidance on the use and maintenance of Self Propelled Modular Trailers, as well as on the engineering of SPMT work and training of personnel. It is presently available in six languages.

Best Practice Guide for Transport and Installation of WTG Systems

In close cooperation ESTA and VDMA have produced a Best Practice Guide addressing the transport and installation of Wind Turbine Generator systems on land.

ESTA communication

With the ESTA website, each member has the possibility to contact other ESTA members, in each European country, to work together under the same general conditions and standard of ESTA safety and quality. With the help of manufacturers and customers, ESTA wants to promote throughout Europe safer and better working conditions to minimize accidents.

Network

ESTA has contacts with permitting authorities in many EU countries and is a member of the International Road Transport Union and the International Crane Stakeholders Assembly.
